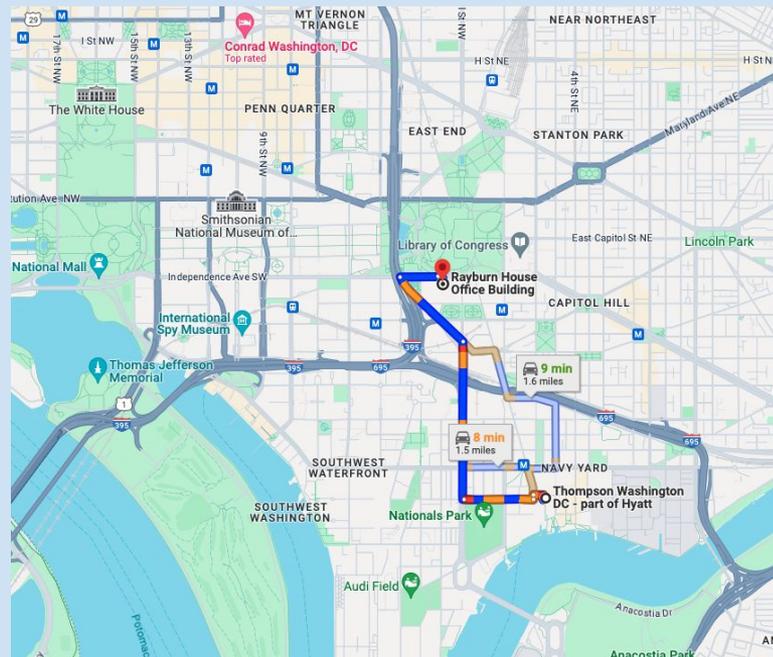

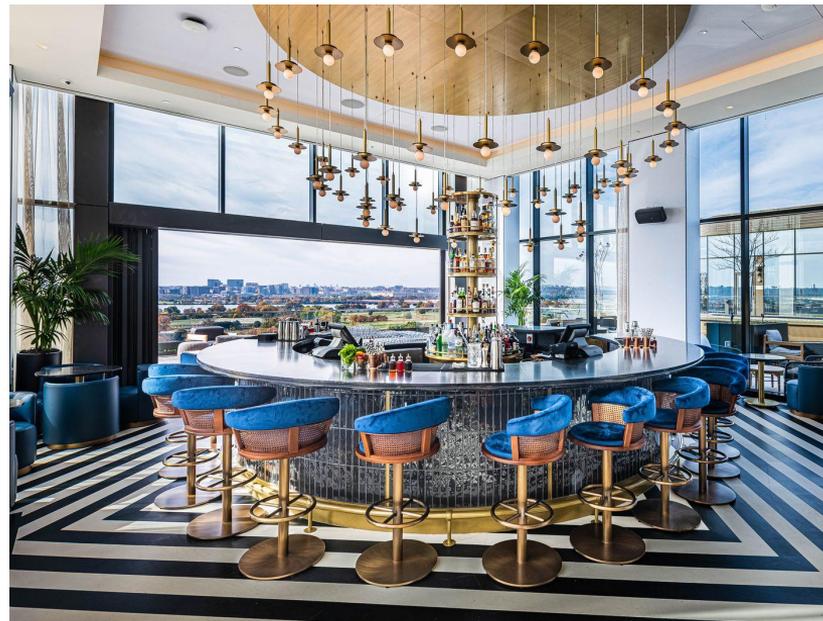

BACKDROP | What is Stand with Crypto?

WHAT - Stand With Crypto is a 501c4 – a political advocacy non-profit – dedicated to activating the 52-million strong crypto constituency by giving them a hub of tools to quickly and easily raise their voice in favor of pro-crypto policies.

- Launched with Coinbase’s support in August 2023, the movement has grown to over 2.1m+ advocates nationwide.
- Coinbase and Stand With Crypto have hosted successful town halls, rallies, and virtual and in-person events across countless U.S. cities.
- StandWithCrypto.org features a call / email maker tool that allows advocates to contact their members of Congress with a single click.
- SWC has state chapters and provides updates on local meetups, legislative developments, and advocacy opportunities, with over 716k+ touchpoints with policymakers.

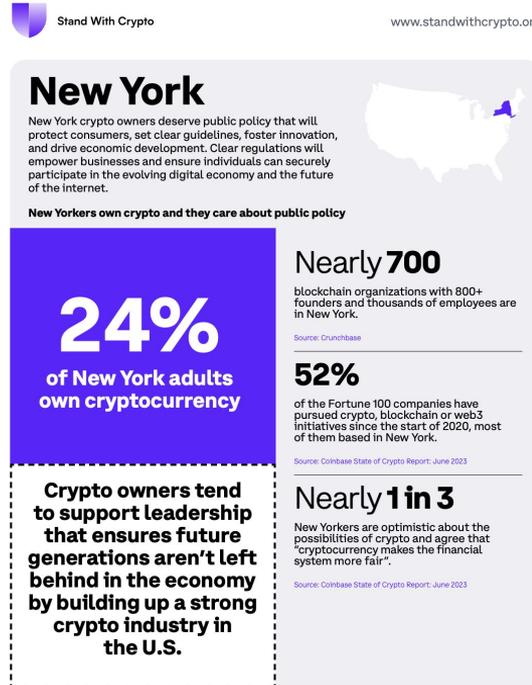

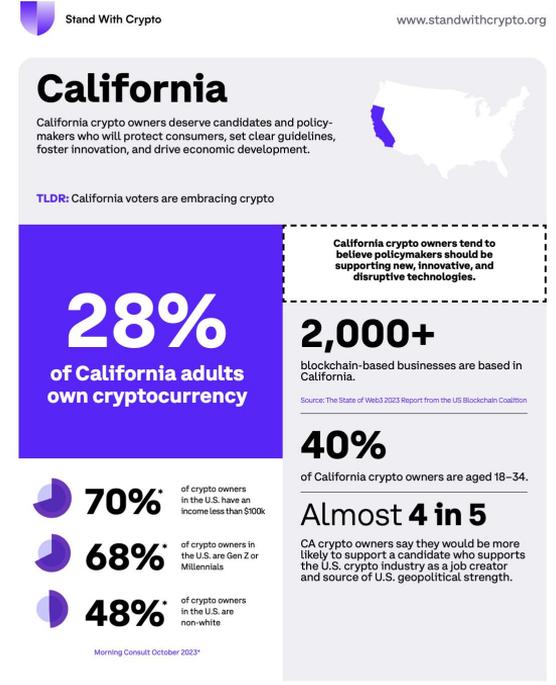
GOAL | Communicate the Power of the Crypto Constituency

TLDR; 52 Million Americans Own Crypto

- **5x more** Americans than *own an EV*
- **3.5x more** Americans than *belong to a Union*
- **2.75x more** than *attended an NFL game last season*
- **2x** American families who *directly hold stock*
- **1.3x more** American than *using ridesharing every month*

 - Wednesday 3/5: Suits or blazer and slacks



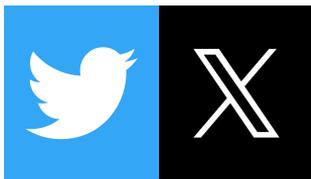

Document meetings with photos to add to your posts – action shots during meetings and group shots with representatives, senators and your cohort.

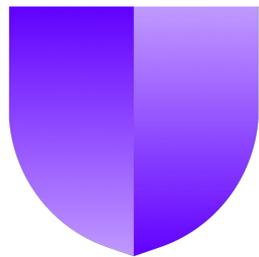
